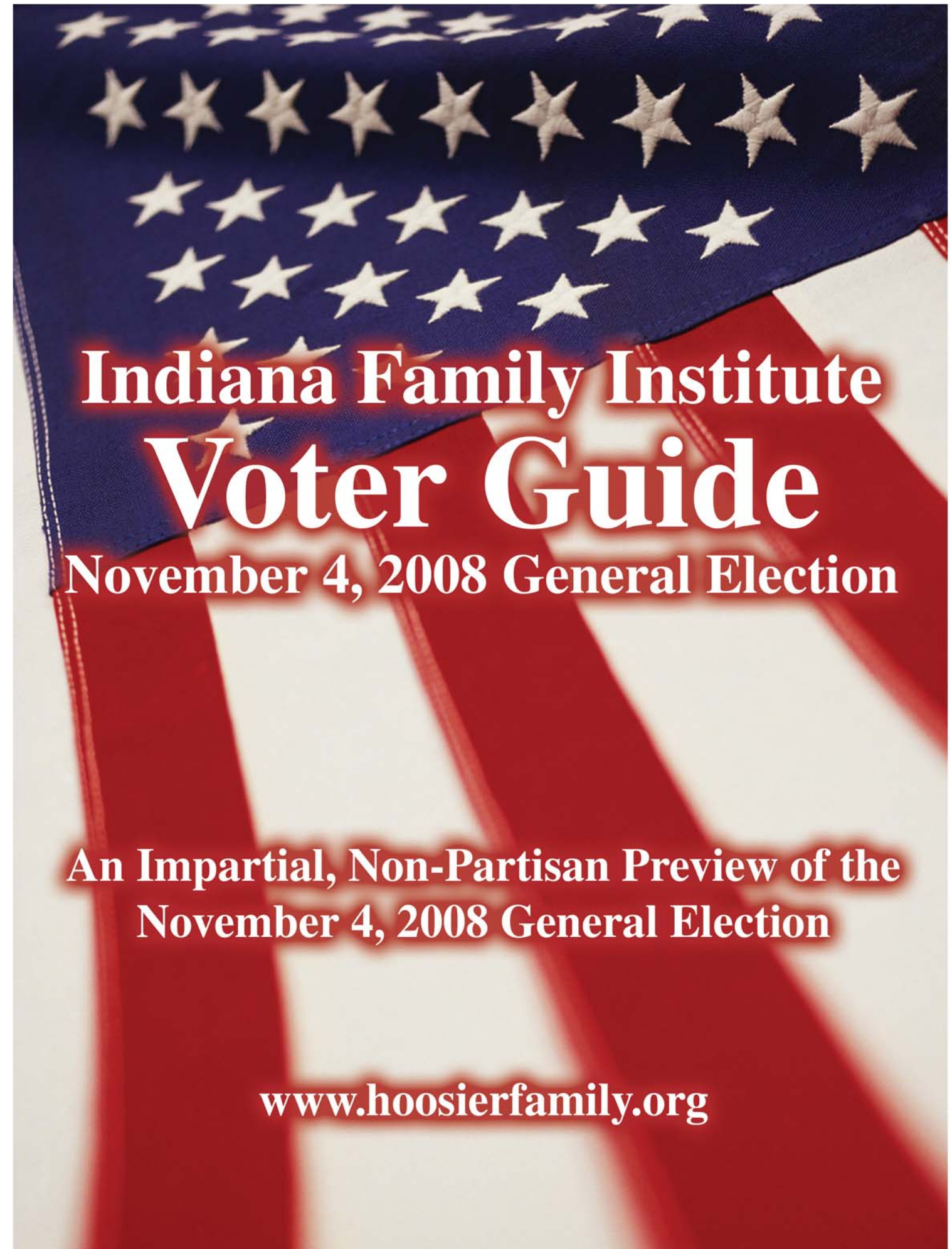

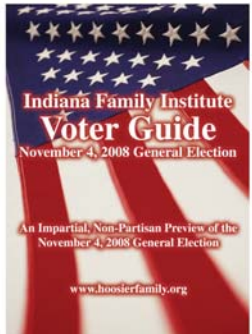

**What’s inside?**

Races included in this guide are U.S. House of Representatives, Governor, Lt. Governor, Attorney General, Superintendent of Public Instruction, State Senate and State House of Representatives. Members of the U.S. House, State Senate and State House are elected by legislative district. Governor, Lt. Governor, Attorney General and Superintendent of Public Instruction are on all Indiana ballots. Due to ongoing court cases regarding whether judges can respond to questionnaires and lack of response during the last election cycle, we did not mail questionnaires to judges. We did not survey candidates for President given the plethora of information already available on that race. Contact your county courthouse to find out which judges and other elected offices not included in this Voter Guide will be on your ballot on Election Day and how to get in touch with them.
